### 1. Approval item: Minutes from September 6, 2017 Meeting

Vice-Chairperson Wanner asked the committee members to review the minutes. Mr. Barry House made a motion to approve the minutes, the motion was given a second by Mr. Chris Mayhew. The minutes were approved with no objections.

### 2. Safety Performance Targets

Mr. Barry House presented information to the committee related to Safety Performance Targets. National performance goals for the Federal-aid highway program were established in MAP-21 and continued in the most recent Federal transportation bill, the FAST Act. USDOT is required to establish performance measures in each of the seven goal areas: safety, pavement condition, bridge condition, traffic congestion, mobile source emissions, and freight movement. The first area to address is safety. By February 27, 2018, the MPO must establish safety performance targets for the metropolitan planning area or formally agree to support the targets set by KYTC. KYTC established performance targets for safety include: Fatalities – 730; Serious Injuries – 2,800; Fatality Rate – 1.50; Serious Injury Rate – 5.76; and Non-motorized fatalities/serious injuries – 293. Barry suggested and the committee agreed that the best option for the MPO is to support KYTC's targets. This information will be presented to the Policy Committee at their January meeting.

### 3. Bicycle Facility Improvements

Mr. Mike Skaggs opened the discussion on bicycle facility improvements by presenting the proposed improvements from the Bicycle Facilities Plan completed in the fall of 2016. Mr. Ed Poppe said that it would be up to each individual jurisdiction to implement the projects on the routes in their particular area. This will be done through the budgeting process and the local comprehensive plan. These routes can also be implemented by working through local bicycle clubs and trail groups to ensure connectivity. Mr. Barry House mentioned that he had discussed the plan with Troy Hearn who suggested that each project be distinguished as needing sharrows, signage, or both. He also mentioned that the plan currently has incorrect photos for bicycle signage. The committee also discussed the bike lane on KY 361 not having proper buffering and the proposed St. John Road (KY 1357) improvements including a shared use path. The KYTC staff mentioned that interest in bicycle improvements should be shared with the planning teams on an individual project basis.

## 4. FY 2019 Draft Unified Planning Work Program (UPWP)

Mr. Skaggs mentioned that the MPO staff would soon begin work on the draft UPWP, which is due each year to state and federal partners by the end of February. The funding levels for FY 2019 will be received in January and any special project requests will also be due in January. He asked the committee about the need for any special studies that may need to be conducted. Mr. Murray Wanner brought up the possibility of developing a regional ADA Transition Plan. Some work has been done in a couple of jurisdictions on the MPO but more work is needed toward meeting the ADA Transition Plan requirements. Mr. Skaggs said he would bring this before the MPO Policy Committee at their January meeting to get their feedback and approval if they deemed such a study to be necessary. Mr. Skaggs asked about any other potentials studies to which there was no feedback.
