

MINUTES JANUARY 26, 2023 RADCLIFF/ELIZABETHTOWN MPO POLICY COMMITTEE

The Radcliff/Elizabethtown MPO Policy Committee met on Thursday, January 26, 2023 at 10:00 a.m. in the LTADD Boardroom. Those in attendance were:

Chairman Jeff Gregory called the meeting to order at 10:00 a.m.

The first agenda item was consideration of the minutes from the October 13, 2022. Mayor Bryan Claycomb made a motion to approve the minutes, seconded by Mr. Isidro Delgado. Motion carried.

The second agenda item was a presentation providing an overview of the MPO and its functions. Mr. Mike Skaggs gave the presentation the covered, What is a MPO?, Roles of the MPO, Key Documents, MPO Special Studies, and the MPO's Role in Project Prioritization.

The third agenda item was review and discussion of the draft Unified Planning Work Program (UPWP) for FY 2024. Mr. Skaggs gave a brief overview of the Policy Committee Bylaws, the work elements included in the UPWP, the committee structure, and the budget and local match for FY 2024.

The fourth agenda item was review and discussion on the Strategic Highway Investment Formula for Tomorrow (SHIFT) 2024 prioritization process. Mr. Skaggs gave an overview of how SHIFT works, the Continuous Highway Analysis Framework (CHAF) database and process for adding new projects, the SHIFT 2024 schedule, project sponsorships, and boosts. He indicated that the process is open now for new projects and will continue through the spring with the MPO working on the sponsoring of projects.

The fifth agenda item was election of a Vice-Chairman for the Policy Committee. Judge Troy Kok was recommended by Chairman Gregory and he agreed to the position should the committee vote agree. Mayor Bryan Claycomb made a motion to approve Judge Kok as Vice-Chairman, the motion was seconded by Judge Keith Taul. Motion carried.

The committee also discussed whether a change was needed in the regularly scheduled meeting date for the Policy Committee. The committee agreed to keep it as is (2nd Thursday, Quarterly).
